Four key areas of the plan include safety, parent engagement, academics, and citizenship.

B. Public Hearing Notice to Present the Proposed Kenwood School District Budget for the 2023-2024 School Year. The district is fiscally sound and all funds have positive balances. However, many challenges lie ahead for the KSD. California has enjoyed record revenues, and as a result, has provided one-time funding to schools through numerous programs. In the 2023-2024 State budget, it is apparent that the economy will not be able to sustain the increases of the past. We will not be seeing as many State program funds going forward. Deficit spending will be expected as the one-time program dollars are spent without new revenue. The Superintendent and staff will continue to work with the Board to find cost savings to reduce projected deficits in the subsequent fiscal years.
